- **Meeting Call to Order:** by President Tom Bakken
- **Roll call of Directors:** by Secretary Chris Faste:
  - ***Present;*** Doug Hoese, Tom Bakken, Chris Faste, Ken Staloch, Jesse Szykulski, Nick Caver, Dan Grinsteinner, and Jim Williamette
  - ***Absent;*** Richard Regnier, Scott McKown, Doug Whitney, and Chad Lunder
- **The January 5<sup>th</sup> Chapter Meeting Minutes:** approved by board members
- **Code Corner:**
  - Doug Hoese asked members which footing sizes they have been apply according to building codes definition of a story. He received confused looks for an answer
- **State Code Division and Legislative Report:** Steve Hernick stated;
  - There a pending “Moratorium Bill” on Code Regulations, that had to keeping the code requirements at their current adoption,
  - Also added that the all the State Code Committee’s are rapping up for 2013 code / rule adoption
    - Every 2 years there is a required review of memorandum
    - Talk of reducing the State Building Code surcharge from 5 dollars to .50 cents
    - State will have education code seminars in the spring of 2012
    - Plumbers have changed the requirement of “License and bonded,” to just “Licensed” do to the fact that if they are licensed they automatically have the bond
    - Tech advisory council needs to be completed
    - There are too many amendments to the ‘I’ codes from the State code committees. It has been bogging down the adoption of the Minnesota State Building Codes
- **ICC Report:**
  - Scott Holm encouraged 10k members to join an ICC committee
- **AMBO Report:**
  - Region Three Annual School was well attended with over 500 people, with positive feedback
  - The facilities was a success and AMBO is in the process of making “Oak Ridge” the new location for the school

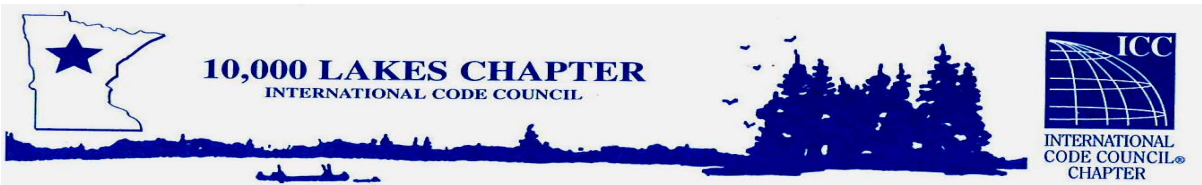

## Categories of Membership

Each Governmental Member shall be entitled to the number of voting representatives specified below. These Governmental Member Representatives shall be designated in writing and shall be employees or officials of the Governmental Member as stated above.

0 to 50,000	4
50,001 to 150,000	8
Over 150,000	12

All Governmental Member employees or officials in excess of voting representatives shall be an Associate Member.

**Associate Member:** An employee of a governmental unit, department or agency who is not designated as a Governmental Member Representative.

**Corporate Member:** An organization such as, an association, society, testing laboratory, institute, university, college, company, manufacturer or corporation interested in the purposes and objectives of the Chapter.

**Cooperating Member:** An individual who is interested in the purposes and objectives of the Chapter.

**Professional Member:** An individual who is engaged in the practice of engineering or architecture and duly licensed or registered by any state or other recognized governmental agency.

**Honorary Member:** An individual who has rendered outstanding service to the Chapter, and whose name shall be proposed by the Board of Directors and confirmed by a majority vote of the Governmental Member Representatives at a Business Meeting.

**Student Member:** Any individual enrolled in classes or a course of study qualifying for occupying at least eight semester credits of classroom instruction per school year.

**Retired Member:** Any former member who is retired.
